Eu Yan Sang seals a joint venture deal to be one of the largest exporters of high quality TCM herbs from China

- **Joint venture with Chengdu-based Sichuan Neautus Traditional Chinese Medicine Co Ltd aims to upgrade Eu Yan Sang's supply chain and improve the Group's margins.**
- **The JV plans to set up a TCM decoction pieces (processed herbs) plant in China with an online traceability feature and responsibility in sourcing of herbs.**
- **The collaboration is expected to provide better sourcing capability for high-grade raw materials to further improve on public trust and confidence in TCM herbs.**

Singapore, 16 May 2013 – SGX mainboard-listed Eu Yan Sang International Ltd (“EYS”, “the Group” or “余仁生国际企业”), a trusted global integrative healthcare and wellness company with a strong foundation in Traditional Chinese Medicine (TCM), will form a joint venture to set up a high quality TCM decoction pieces (processed herbs) plant in China. The partnership enables EYS to be one of the largest exporters of TCM herbs from China and reinforces the Group's commitment to reliability, trust and integrity of its products.

On 11 May 2013, the Group's wholly-owned subsidiary, Eu Yan Sang (Hong Kong) Limited (余仁生(香港)有限公司) has inked an agreement with Chengdu-based Sichuan Neautus Traditional Chinese Medicine Co., Ltd. (Sichuan Neautus, 四川新荷花中药饮片股份有限公司) to co-establish EYS NEAUTUS (Sichuan) Company Limited (仁生荷花中药(四川)有限公司). The joint-venture (JV) company will be based in Chengdu Hi-Tech Zone for the setting up of the TCM decoction pieces (processed herbs) plant.

The JV agreement also entails the subsequent setting up of a sales office in Hong Kong, EYS NEAUTUS (Hong Kong) Limited (仁生荷花(香港)有限公司), a trading company managing the overseas sales.

The 50/50 joint venture is expected to improve the Group's margins through lower costs of raw materials and strengthening the upward integration of the Group's supply chain. The Group will also stand to benefit in ensuring a timely, trusted source of herbs and ingredients for its renowned products.

Sichuan Neautus, which has an existing, reliable computerised system to trace herbs from source, will bring intangible value to the JV such as improving the sustainability and responsibility of sourcing for high-grade raw materials.

The JV will incur RMB40 million (approximately S\$8.0 million) for Phase One, which is the setting up of the Good Manufacturing Practice TCM decoction pieces (processed herbs) plant in Chengdu Hi-Tech Zone, Sichuan province.

Commenting on the JV, Mr. Clifford Eu (余义方), Group Managing Director, International, EYS, said: "We are delighted to be working with Sichuan Neautus, an established company in the decoction pieces industry in China. This agreement is fully aligned with EYS's current practise of providing high quality and safe TCM herbs to the global market by leveraging on Sichuan Neautus's strengths. This JV will open new sales channels, be an authority and trailblazer as a trusted brand in TCM international market."
